

Privacy Policy for Maple Leaf Legacy (Nevada)

1. Introduction

2. Information We Collect

We do not collect sensitive personal information unless explicitly provided by you.

3. How We Use Your Information

We use your information to:

4. SMS/Text Messaging Policy (10DLC Compliance)

4.1 How We Obtain Consent

You may opt in to receive SMS messages from Maple Leaf Legacy through one of the following methods:

- **Website form:** You provide your phone number and check a box agreeing to receive text messages.
- **Keyword opt-in:** You text a designated keyword to our Grasshopper number.
- **Paper form:** You provide your number and consent in writing.

We maintain records of opt-ins as required by carriers.

4.2 Message Types

With your consent, we may send:

- Informational updates
- Appointment or service-related messages
- Occasional marketing or promotional messages (only if your opt-in method allows it)

4.3 Messaging Terms & Conditions

By providing your phone number and agreeing to receive texts, you consent to receive text messages from Maple Leaf Legacy from **702-848-2005** regarding informational and/or marketing content. Consent is not a condition of purchase. Message frequency varies. Message and data rates may apply. You may opt out at any time by replying **STOP**. Reply **HELP** for assistance. 4.4 Data Sharing (Carrier-Required Disclosure)

- Customer data is not shared with third parties for promotional or marketing purposes.
- Mobile opt-in and consent data is never shared with anyone for any purpose.
- Any information sharing described elsewhere in this policy excludes mobile opt-in data.

We take reasonable administrative, technical, and physical measures to protect your information from unauthorized access, disclosure, or misuse.

- Comply with legal obligations
- Protect our rights
- Work with trusted service providers who assist in business operations (e.g., website hosting)

These providers are required to safeguard your information.

Our services are not directed to individuals under 13. We do not knowingly collect information from children.
